## **NO OBLIGATION TO RETURN TO INDIA (NORI)**

'No obligation to Return to India' (NORI) certificate is required to those Indian nationals who has gone United States of America with J-1 VISA

For this purpose, the applicant has to apply in proper format through the concerned Embassy of India/ Consulate General of India in USA / Canada.

On receiving the application, endorsed by the concerned Embassy of India/ Consulate General of India in USA, the Foreigners Branch will forward the case to the jurisdictional Superintendent of Police, District Intelligence Branch, or Special Branch, in this State for enquiry of the local address as referred by the applicant. If satisfactory report is received from the concerned SP, DIB, the 'NORI' certificate is issued in favour of the applicant, from <u>Home Department,</u> <u>Foreigners Branch, Government of West Bengal, Writers Buildings, Kolkata-</u> <u>700001.</u>

## **NO OBJECTION TO RETURN TO INDIA (NORI)**

Grant of NORI(No Objection to Return to India) to Tibetan Refugees/Tibetans intending to visit abroad

Tibetan Refugees/Tibetans intending to visit abroad for a short duration up to 15days shall travel only on the strength of the Identity Certificate (IC) issued by theMinistry of External Affairs/ Regional Passport Officer and would be required toobtain 'No Objection to Return to India (NORI)' permission from the FRRO/StateGovernment. If intended visit abroad requires absence from India for a periodmore than 15 days, such Tibetan Refugees/Tibetans would be required totake exit permission from the concerned FRROs/FROs and report arrival to them oncoming back to India.

NORI in case of less than two weeks or Exit permission in case of more than two weeks would be granted by the concerned FRRO/State Government on the recommendation of CTA (Central Tibetan Association) or any other authority so designated by the Central Government subject to nothing adverse and no local objection of theconcerned FRRO/State Government.

## POLICE CLEARANCE CERTIFICATE (PCC) for FOREIGN NATIONALS

The foreigners, who are residing in India or have resided earlier in India, may require Police Clearance Certificate. For this purpose, a foreigner has to apply online through <add link<a href="https://indianfrro.gov.in/frro/">https://indianfrro.gov.in/frro/</a> according to his/her present or previous Indian address.

The FRO will process the case and forward the case to this Deptt, i.e. STUT, Kolkata for approval.

This Deptt will grant the PCC through online after verification of the uploaded documents including the report regarding security clearance from the concerned FRO.

## POLICE CLEARANCE CERTIFICATE (PCC) for INDIAN Nationals staying abroad or going to abroad for Employment and some other specific purpose

Indian nationals who are presently staying abroad or going to abroad for Employment or some specific purpose, may apply for POLICE CLEARANCE CERTIFICATE, in proper format and send the filled in application form with relevant documents to:-

On receiving the application along with copies of supporting documents, this Branch conducts enquiry through the concerned Police authorities. If satisfactory report comes from the police authorities, the POLICE CLEARANCE CERTIFICATE is issued in favour of the applicant. Such an applicant may send the filled application form directly to the concerned Commissioner of Police/Deputy Commissioner of Police/Superintendent of Police, who will forward the report after enquiry, to the Foreigners Branch for issuing the PCC.
