- ❖ In case of submission of application, for any cases mentioned above, beyond the date of validity of VISA, fine (as applicable) is to be deposited for such overstay. Required form for deposit of fine is to be collected from concerned office.
- In case of 'exit refusal' at border on the day immediately after the date of expiry of authorized stay in India, no medical certificate is required, if applied for permission to leave India within the next working day.
- In case of a person holding Official Passport, all the above procedures for extension of stay in India shall apply only after a period of 45 days starting from the date of entry in India. The person may have to submit other documents like leave sanction order etc.
- ❖ In case of person seeking extension of VISA stays at Hotel / Lodge during that period, he / she has to submit 'Form C', instead of Sponsorship Certificate, issued by the Hotel / Lodge authority as per the prescribed format.
