Sub: Creation of 27 (twenty seven) regular posts in different categories under West Bengal Police and engagement of 01 (one) Karmabandhu on part-time basis for Bhorer Alo Police Station at Gajaldoba under Siliguri Police Commissionerate.

- 1) In terms of this Department's Notification No. 949-PL/PB/4P-09/19, dated 17.04.2023, Notification No. 950-PL/PB/4P-09/19, dated 17.04.2023 and Notification No. 951-PL/PB/4P-09/19, dated 17.04.2023 New Jalpaiguri Police Station, Bhaktinagar Police Station and Bhorer Alo Police Station have been created by way of bifurcation of the existing New Jalpaiguri Police Station and Bhaktinagar Police Station under Siliguri Police Commissionerate.
- 2) Now, the undersigned is directed to say that the Governor has been pleased to accord sanction to the creation of 27 (twenty seven) regular posts in different categories under West Bengal Police on the usual rate of pay and allowances and engagement of 01 (one) Karmabandhu on part-time basis for manning the New Bhorer Alo Police Station as detailed hereunder :-
- (i) Sub-Inspector – 02
 - (ii) Lady Sub-Inspector – 01
 - (iii) Assistant Sub-Inspector – 02
 - (iv) Lady Assistant Sub-Inspector – 01
 - (v) Constable – 15
 - (vi) Lady Constable – 03
 - (vii) Police Driver – 02 (filling up to be made on contractual basis)
 - (viii) Wireless Operator – 01
- Total posts 27
- Karmabandhu on part-time basis - 01
- Total 27 + 1
- 3) 01(one) Karmabandhu on part-time basis may be engaged at a consolidated remuneration of Rs. 3000/- per month to be paid out of Contingency.
- 4) Filling up the required posts must be on observance of extant recruitment rules.
- 5) The charge is debitable to the appropriate Head of Account in the State Police Budget.
- 6) The order issues with the concurrence of the Finance Department vide their U.O. No. Group-P2/2022-2023/0855 dated 15.02.2023. This has also been approved by the Cabinet held on 27.03.2023.
- 7) The Principal Accountant General (A&E), West Bengal is being informed.
